#### **Civil Society Law Reform**

#### Appointment of General Director at the General Directorate of Foundations

After serving for eight years as the Head of General Directorate of Foundations, Mr. Yusuf Beyazit retired and Dr. Adnan Ertem was appointed to his position as of October 13, 2010. Dr. Ertem has served in various positions at the General Directorate and he was serving as a Deputy Secretary to the Prime Minister since 2007.

## **Special Resolution on Freedom of Association and Assembly**

The UN Human Rights Council passed a resolution on "The Rights of Freedom of Peaceful Assembly and Association" on 30 September 2010, drawing to an end a hard-fought campaign by civil society groups, including the International Center for Not-for-Profit Law (ICNL), Article 19, World Movement for Democracy, and CIVICUS: World Alliance for Citizen Participation. The resolution represents a major win for civil society globally, as freedom of assembly and association are the key pillars of civil society space and fundamental to CSO's very existence and operations. It comes as a meaningful and hopeful development, considering increasing attacks and shrinking space for its operations. The resolution was co-sponsored by 63 countries and passed by consensus. A cross-regional group, including the Governments of Indonesia, Nigeria, Mexico, Lithuania, the U.S., the Czech Republic, and the Maldives, co-tabled this resolution. Among other items, the resolution establishes a Special Rapporteur on Freedom of Association and Assembly to monitor and report on violations of these rights. # Highlights on Civil Society in Europeans Union's 2010 Progress Report

The report is prepared and published annually by the European Commission during the first week of November, Turkey's Annual Progress Report gives an overview of the current situation in the country with respect to its accession process to EU. The report analyzes the extent of fulfilment of economic and political criteria and the ability to assume the obligations of membership under the 33 topics of negotiation. The report also assesses civil society's environment and impact through its ability to influence policy decisions, level of participation in the policy-making processes and the level of freedom of association in Turkey, as well as the legal framework concerning civil society organizations. ## Black Sea NGO Forum, 21-23 October 2010, Romania

Every year, Black Sea NGO Forum invites civil society representatives from the Black Sea region to participate on an international forum. This year's third round titled "Investment to Our Common Future" was held on 21-23 October 2010 in Constanta, Romania. The hosts of this year's forum, Romanian Civil Society Development Foundation, Romania NGO Federation, and Romanian Ministry of Foreign Affairs, European Commission and German Marshall Fund of United States welcomed around 200 participants for this event. The main topics included democracy and citizen participation, sustainable economic development, establishment of international donors, youth politics, climate change and social media from the civil society perspective. Additionally, program was enriched by the presentations of NGOs and an NGO fair. During the event, TÜSEV presented a report on Developing Strategy for Civil Society in the Black Sea Region which is

the result of a regional workshop took place in Istanbul during the ISTR Conference in July 2010. ## Turkey Ranks 134<sup>th</sup> in the World Giving Index

The World Giving Index is the first report of its kind looking at charitable behaviour across the world. Using data from Gallup's Worldview World Poll, Charities Aid Foundation (CAF) looked at three different types of charitable behaviour: giving money, giving time and helping a stranger. Out of 153 countries included in this survey, Turkey ranks in the 134<sup>th</sup> place. According to the report, 14 % of Turkish people give money, 7 % give time and 35 % help a stranger. The survey also revealed many interesting facts and contrasts between countries. For instance, helping a stranger was the most widespread form of charitable behaviour. In addition, while charitable behavior percentages varied depending on wealth level, age was not a determining factor for the donor. Australia and New Zealand topped the World Giving Index, while Sri Lanka, Turkmenistan and Guinea ranked in the top 20. The full report is available in English and can be reached at the CAF website.

## The Muslim Philanthropy Digital Library (MPDL) is Launched

The Muslim Philanthropy Digital Library (MPDL) seeks to make a repository of the world's knowledge on all forms of philanthropy as expressed through original documents, reports, graphics, waqf registrations, scholarly analysis in Muslim-majority countries and Muslim communities. Launched in October 2010, the digital library covers material from 1900 to the present and includes original source documents, annual reports, *waqf* registrations, scholarly analysis and other relevant material. It encompasses the diverse cultural, political and social factors influencing the practice of local philanthropy as well as the significant contributions from Muslim-majority countries to global philanthropic practice. #### **Umut Foundation Objects the Draft Law on Guns/Firearms**

The Parliament's Internal Affairs Subcommittee has approved the Draft Law on Guns/Firearms which decreases the age limit for owning a shotgun to 18, angered advocates of individual disarmament but pleasing gun lobbies. "The new law will ultimately only encourage young people to arm and result more violent society", said Nazire Dedeman, President of the Umut Foundation, a leading anti-gun organization. Following the Subcommittee's decision, a group of civil society organizations including Umut Foundation successfully mobilized the public opinion against the draft law and caused its suspension. Umut Foundation is fighting against individual arming in Turkey where each year almost 3000 people die because of gun violence.
