Survey on the Freedom of Association is Launched

Funded by the European Union's European Instrument for Democracy and Human Rights (EIDHR), Preparation of Methodology for the Monitoring of Freedom of Association in Turkey Project was launched in January 2009 by Third Sector Foundation of Turkey (TUSEV) in partnership with the Civil Society Development Centre (STGM). Under the project, TUSEV and STGM had worked to prepare a "user friendly" online-survey as a pilot methodology to capture the realities of freedom of association in Turkey and to pool common concerns of different stakeholders regarding this issue. The Survey on the Freedom of Association is designed uniquely for associations and is only available in Turkish at the moment. The survey is made up of 60 questions pertaining to various issues that include: registration procedures, initiation of members, track of documents, general assembly, audit, international relations, memberships, fines, taxes and activities related to the Press Law, Meeting and Demonstration Law and Aid Collection Law. The survey aims to define the major obstacles for CSOs and identify the initial concerns that need urgent attention. Highlights on Civil Society in Europeans Union's 2009 Progress Report

The Turkey 2009 Progress Report was published on 14 October 2009. The report monitors the reform efforts of the previous year and outlines the current status of Turkey in the EU accession process. The report acknowledges that Turkey has made noteworthy progress in the accession process, it reiterates the fact that future reforms are needed in order for Turkey to become more in line with European standards. ECNL Report on Accountability and Transparency in EU

The European Commission Directorate-General of Justice, Freedom and Security (DG JFS) published the Study on Recent Public and Self-Regulatory Initiatives Enhancing NPO Transparency and Accountability of Non-profit Organizations (NPOs) in the European Union. The report was developed by the European Center for Non-for-Profit Law (ECNL). DG JFC commissioned ECNL to conduct research and put together a study that catalogs and assesses the recent and most important NPO public and self regulatory measures enhancing transparency and accountability in the 27 EU member states. The Study was constructed in the hopes that it will improve dialogue and increase knowledge by identifying and helping to develop best practices through comprehensive case studies. The research also aims to provide effective policy recommendations for NPOs, regulators and policymakers themselves. In addition, Study considers measures to enhance NPO transparency and accountability in the overall context of international and European initiatives to address the risk of NPOs being used as a means to financing terrorism. Overall research showed that there is significant interest in accountability and transparency in the EU, due in large part to the increasing role and impact of NPOs. Furthermore, the Study identified over 140 initiatives in the field of public regulation and self-regulation and of these 19 were analyzed in-debt in the report. WB-IMF Annual Meetings, Civil Society Policy Forum, 2-7 October 2009, Istanbul

The 2009 World Bank and International Monetary Fund (IMF) Annual Meetings were held on October 6 and 7, 2009 in Istanbul, Turkey. The Bank and IMF Civil Society Teams also organized a Civil Society Policy Forum between October 3 and 7 2009. The program also included a Townhall Meeting with the Bank's President Robert B. Zoellick and the Fund's Managing Director Dominique Strauss-Kahn. TUSEV sponsored the "Civil Society in Turkey" Panel, aiming to give the audience a sense of where Turkey stands in the global civil society movement, the sector's strengths, weaknesses, challenges and opportunities ahead. While panelist Henri Valot (CIVICUS) gave an overview of the state of civil society in the world, Zeynep

Meydanoğlu (TUSEV) and Emrah Göker (YADA Foundation) presented the preliminary findings of recent studies on civil society in Turkey. For further information please click here.

The CSI Indicator Database was developed in order to ensure the availability of civil society data collected in the 2003-2006 phase in the CSI programme to a global audience. An England-based organisation, National Council of Voluntary Organisations (NCVO), has spearheaded the establishment of this new network, which promises to fill an important gap in promoting communication and cooperation between national associations in the EU and its neighbourhood.
