### Civil Society Law Reform

#### Elections Held for the II. Term of the Council of Foundations

A Council of Foundations composed of representatives of foundations as well as public officials was established as the highest decision-making body of General Directorate of Foundations (GDF) after the adoption of a new Law on Foundations in 2008. The elections for the 5 seats allocated to foundations' representatives for the second term of the Council was held on December 25th, 2011. Süleyman Savat, İslam Emiroğlu, and Ahmet Özdemir were elected as the representatives of "new" foundations (established after 1923) while Bilal Sarı and Pandeli Laki Vingas will represent "old" foundations established by non-Muslim minority communities and Muslim founders during the Ottoman Era.

# Regional Policy Dialogue between Governments and CSOs- Regional Conference Partnership for Change, Belgrade, 15th March

A Regional Conference "Partnership for change: Civil Society and the Governments in the Western Balkans and Turkey" will be held in Belgrade on March 15th organized by the Office for Cooperation with Civil Society of the Government of the Republic of Serbia in the partnership with BCSDN, Office for Cooperation with NGOs of the Government of the Republic of Croatia and TACSO. This conference will for the first time bring together representatives of the Governmental institutions responsible for cooperation with CSOs and CSOs from the Western Balkan and Turkey in direct discussion on most pertainent issues such transparent financing of civil society and consultation process. The conference will continue the regional exchange and cooperation between Offices started at a joint workshop held in Skopje in March, 2008, but by including representatives of CSOs. The conference is not aimed to be a one-off event, but rather a new impetus to a structured and effective regional cooperation between the Offices and their cooperation with CSOs and will be followed up within the framework of the BCSDN project Cross-Sector Regional Partnership for Enabeling Environment for Civil Society Development.

Topics as; regulation of CSOs, funding of associations, government supervision, reporting & sanctions were discussed thoroughly align with the Draft Law on associations. The Conference is organised by TUSEV, British Council, and TACSO Project. The strategic partner of the Conference was the Vodafone Turkey Foundation, while the Kadir Has University was the host. This conference gathered 150 participants from the Western Balkans, Turkey, Ukraine and Georgia and United Kingdom. During the two days the participants created an important opportunity for the development of social entrepreneurship in the region. "In the last two years, TÜSEV has devoted a lot of effort to the development of social enterprises in Turkey", said Prof. Üstün Ergüder, Chairman of the Third Sector Foundation of Turkey during his welcoming speech. "The Conference will complement these efforts, as it presents a unique opportunity for all who are involved in the social entrepreneurship field to share experience and knowledge and to network with counterparts from more than 20 countries. We hope that the discussions will inspire both civil society organisations and individual entrepreneurs to start or develop their social enterprises and to become more innovative while approaching social problems." # Education Reform is on the Spotlight of NGOs in Turkey

On February 23rd, National Education, Culture, Youth and Sports Commission at the Grand National Assembly of Turkey has submitted a draft bill to the Parliament.

According to the bill, the current eight years of compulsory education, which only includes a primary school education,


will be extended for another four years of high school education. However, the compulsory 12 years of education will be divided into three levels: four years of primary school, four years of middle school and another four years devoted to high school education. Women, disabled, and education NGOs as well as experts are protesting the bill affirming that the bill paves the way for different types of schools to intervene and take up the education of children. According to the experts, the proposed structure may propagate child labor, jeopardize efforts towards inclusive education and harm the right to education of girls. #### The World Youth Report 2011 Released

Published by the UN Department of Economic and Social Affairs (UNDESA), the World Youth Report, entitled Youth Employment: Youth Perspectives on the Pursuit of Decent Work in Changing Times outlines the situation of young people in the labour market and youth employment trends.



Young people and representatives of youth-led organizations were invited to share through digital and social media platforms their views, experiences and recommendations on preparing for, entering, and remaining active in the workforce. A total of approximately 1,100 contributions (as well as photos and videos) were received from young people around the world during the four-week consultation period. #### NGO's Share the Dream of the Sabancı Foundation

The 2012 application process for the Social Development Grant Program has been completed on February, 24th. Through the Social Development Grant Program, Sabanci Foundation supports projects of NGOs that aim to create equal opportunities and active participation of women, youth and persons with disabilities in the society. A total of 192 projects from 45 provinces have applied to

Program to change the lives of women, youth and persons with disabilities. The applications are subject to a preliminary screening held by the Sabanci Foundation team and independent experts. Following the preliminary screening, an independent Evaluation Committee reviews the applications and prepares a short list of grantees. The minimum grant to be allocated for a project in 2012 is 40.000 TL and the maximum is 200.000 TL. A total of 1,2 million TL has been earmarked for the grants.

### **TEGV Volunteering Conference**

Annual 'Volunteering' conferences, which Turkih Education Volunteers Foundation (TEGV) organised in Istanbul for the 6th time on the International Volunteer Day 5 December 2011, now has a theme of 'Volunteer! Make a Difference' to mark European Year of Volunteering and 10th anniversary of United Nations International Year of Volunteering. While the first ever "United Nations State of the World's Volunteerism Report" was launched in New York on 5th of December 2011 at the United Nations General Assembly and in many countries around the world; a national launch in Turkey took place on the same day.
