New Approaches in Civil Society Conference, November 21-22

Within the scope of its 20th year anniversary, TUSEV will organize a two-day international conference entitled "New Approaches in Civil Society" on November 21-22, 2013 in Istanbul. The conference aims to provide CSOs and other stakeholders with a platform for sharing future projections regarding "the next 10 years of the civil society" and discussing innovative solutions to societal problems in light of TUSEV's "New Trends in Civil Society Research". This conference is intended to be the first edition of bi-annual gatherings for civil society organizations. Through this conference TUSEV seeks to create common platforms to exchange best practices and ideas, facilitate cooperation between Turkish civil society organizations, their international counterparts and donors. TUSEV has Launched English Version of the Civil Society Monitoring Report 2012

TUSEV has launched the English translation of Civil Society
Monitoring Report 2012 with financial contributions from
the Chrest Foundation, Open Society Foundation Turkey
and the German Marshall Fund. Civil Society Monitoring
Report 2012 reports on the strength and overall viability of
non-profit sector in Turkey, as well as highlighting
advances and setbacks in 2011-2012 period. This year's
report provides information on various aspects of civil

society such as, public sector-CSO relations, legal and fiscal environment, institutional infrastructure and the financial sustainability of the non-profit sector, governance of CSOs and international relations. The Monitoring Report aimed to open up a discussion on the role and impact of the non-profit sector in Turkey with case studies focusing on CSOs participation in Turkey's new constitution making process, activities and role of the non-profit sector following the Van Earthquake, the role of international donors in supporting Turkish CSO's and media-CSO relations. TUSEV Organized Strategic Philanthropy Workshop with Yapi Kredi Bank

TUSEV has organized a Strategic Philanthropy workshop which was organized in TUSEV office on August 27th, aimed at presenting the Yapi Kredi Private Banking Customer Representatives the elements and applications of strategic philanthropy. Yapi Kredi Bank is the first bank in Turkey which will offer its customers Philanthropy Consultancy as a part of its Private Banking services.

"Strenthening Civil Society and Public Sector Cooperation" Project

As part of the EU funded Project called "Strenthening Civil Society and Public Sector Cooperation" in which TUSEV is an implementing partner, two local consultation meetings organized in Istanbul, on September 9 and 12. During the meetings, the participants form different civil society organizations exchanged their experiences about the obstacles and the conveniences in their relations with the public sector. At the end of the meetings, the participants proposed important points for the making of the Code of Conduct that is going to be designed to regulate the relationship between the cvil society and the public sector as one of the main objective of the Project. Within the scope of the same Project, two more local consultation meetings will be organized in Adana and Diyarbakır in September.



Balkan Civil Society Acquis: Strengthening the Advocacy and Monitoring Potential and Capacities CSOs Project

TUSEV has started implementing the Balkan Civil Society Acquis project which is

coordinated by Balkan Civil Society Development Network (BCSDN) with the partnership of other CSOs located in Western Balkan Countries (Bosnia, Croatia, Kosovo, Macedonia, Montenegro, Serbia, Bulgaria, Romania, and Slovenia). The Project is being financed by the European Union and promotes advancement of Monitoring Matrix on Enabling Environment for Civil Society Development to track progress of third sector and build their capacities. Matrix will be implemented simultaneously in 8 countries mentioned above and the final report will allow comparisons between Western Balkan countries and Turkey. TUSEV organized the national consultation meeting of the project on July 8, 2013, in Istanbul. CSO representatives from different fields have participated in the meeting and discussed the research methodology of the Monitoring Matrix on Enabling Environment for Civil Society Monitoring. TUSEV Will Host the WINGS Forum 2014


TUSEV will host the WINGS Forum 2014 on March 27-29. The theme of the Forum is "The Power of Networks: Building

Hudson Institute's Center for Global Prosperity (CGP) has launched the report on Philanthropic Freedom: A Pilot Study. With this report, the ease of giving has been fully measured and compared

Ecologically Literacy Teacher Training from TEMA

Ecologically Literacy Teacher Training that started for the first time three years ago with the cooperation of Ministry of Education and TEMA Foundation continues to flourish. This year's training was organized between 18th -28th of

June 2013 at Yalova Esenköy Inservice Education Institute. In three years, 249 teachers from 59 cities took part in the Ecological Literacy Teacher Training. These teachers form ecological gardens with their students, organize festivals, exhibitions, plant saplings and explain their students the reasons to not to view the flora and fauna as an endless resource, and how to observe, interpret and communicate with nature.
