The guidelines will be addressed to the authorities in Council of Europe member states and will seek to promote sustainable mechanisms for dialogue, consultation and cooperation between them and civil society. In accordance with the CDDG's decision, a wide public consultation on the draft guidelines is being organized during the summer period before finalizing the guidelines. Civil society and public authorities at all levels are invited to send their comments (in English or in French) on the draft to the CDDG Secretariat by September 4th, 2016. 
