## TUSEV organized a members meeting on 24 November with an aim

Members Meeting: Syrian Refugees in Turkey

to provide information on the situation of Syrian refugees in Turkey.

In the first session of the meeting, Prof. Dr. Ahmet İçduygu from Migration Research Center at Koç University, Selen Elif Ay and Damla Taşkın from United Nations High Commissioner for Refugees provided information on the situation of the Syrian refugees and discussed the main problems they encounter in Turkey. In the second session, Alp Biricik from Human Resource Development Foundation, Burcu Kuğu from Support to Life, Erdem Vardar from Yuva Association and Gizem Demirci Al Kadah from Association for Solidarity with Asylum Seekers and Migrants shared an overview of the work carried out on the field by their organizations in providing support to refugees. In the final session, participants discussed the role of foundations and philanthropic sector in Turkey with reference to Syrian refugees. These main benefits are taken as a starting point to develop an evaluative framework that would enable the field of infrastructure support to measure effectiveness, strengths and weaknesses. 
