TUSEV Attended Dialogue and Cooperation With Civil Society For Better Public Administration Results Conference

TUSEV participated in the regional conference, "Dialogue and Cooperation with Civil Society for Better Public Administration Results", organized by TACSO Regional Office in cooperation with Transparency International Bosnia and Herzegovina on 13-14 March, 2017 in Sarajevo. The conference created an opportunity for experience and knowledge sharing between CSOs and representatives from public institutions on the crucial role CSOs have in the design, implementation and monitoring of public administration reform in Western Balkans and Turkey.



TUSEV Launches Philanthropy Talks

TUSEV launched Philanthropy Talks in order to bring together the Emerging Leaders in Philanthropy Program alumna group and civil society professionals who will share their knowledge and experiences on issues related to the development of philanthropy. Participants will discuss different models of cooperation such as corporate social responsibility, cause marketing and employee volunteering.



TUSEV Members Meeting: Foundations in Turkey

On 20 March 2017, TUSEV organized a members meeting with the participation of Dr. Adnan Ertem, General Director of Foundations. Focusing on the current situation of foundations in Turkey, Dr. Ertem gave information about the implementation of the Law on Foundations and shared his comments on overcoming common challenges faced by Turkish foundations.



TUSEV attended the WINGSForum 2017 which was held in Mexico City on 20-24 February, 2017. In the forum which was themed "Critical Philanthropy: Addressing Complexity, Challenging Ourselves", topics such as providing social change, assessment of the current philanthropy models and applications and creating the suitable conditions for philanthropy to thrive were covered. TUSEV's Secretary General Başak Ersen was one of the panelists in the session named "Connecting the Dots: Working Together for More Effective Civil Society Resourcing", which focused on strategies for linking up disparate actors to enhance support for and understanding of civil society organizations, while challenging existing prejudices and distrust.
