


Sixth Destekle Değiştir was Held on May 27

TUSEV has been organizing Destekle Değiştir (Giving Circle) events, adapted with technical assistance and expertise from The Funding Network, since 2014. Sixth Destekle Değiştir, which is also the first online event in Turkey, was held on May 27. Three civil society organizations presented their projects that focus on providing cinema seminars to university students, providing psychological and legal assistance to youth under state protection, and funding workshops that will teach planting and taking care of plants in houses. 122 people attended the event, and 93 donors pledged a total of 114.350 Turkish Liras (10.825 Euros approx.) to the three projects.



17th Istanbul Biennial exhibitions rescheduled to 2022.


